Biographical Sketch

John Byrne was born on August 3, 1843, in Goodings Grove in Will County, Illinois. He studied law with the firm Spafford and McDaid before graduating from Chicago Law School in 1870 and receiving his State of Illinois Law license in 1871. Prior to moving to Kansas in 1876 and becoming the editor of the Leavenworth Appeal in 1878, Byrne worked in the Chicago Public School system as a teach. He moved back to Chicago in 1879 and returned to teaching. From 1879 to 1882 he was on the faculty of the Chicago Normal School (now known as Chicago State University) before serving as principal of Fallon School (1882), Auburn Park School, and the Dewey School (1900). During his career Byrne was vocal on the subject of public school reform.

Shortly after his appointment to Dewey, Byrne fell ill and passed away on February 11, 1900. He was survived by his wife Mary and 4 children.

Scope and Content

The John Byrne papers consist of 1.75 linear feet spanning the years 1832 – 1936 (bulk 1832 to 1900) and include correspondence, notes, lesson plans, lectures and writings on education, education reform, abolitionism, political issues, and stock certificates and memorabilia from the World's Columbian Exposition of 1893. Original order was maintained according to inventory included with the papers.
